Count 1: POSSESSION OF CHILD PORNOGRAPHY

The above-named defendant on Wednesday, October 30, 2024, in the City of West Bend, Washington County, Wisconsin, did, having attained the age of 18, knowingly possess **Video**: **Jura 4.avi** of a child engaging in sexually explicit conduct, and knew or reasonably should have known that the child was under the age of 18, contrary to sec. 948.12(1m) and (3)(a), 939.50(3)(d) Wis. Stats., a Class D Felony, and upon conviction may be fined not more than One Hundred Thousand Dollars (\$100,000), or imprisoned not more than twenty five (25) years, or both.

And furthermore, invoking the provisions of Wisconsin Statute 973.042(2), upon conviction for a crime under 948.05 or 948.12 and the defendant is at least 18 years of age at the time of the commission of the crime, the Court shall impose a surcharge of \$500.00 for each image or each copy of an image, as defined in 973.042(1), associated with the crime. Stats., a Class D Felony, and upon conviction may be fined not more than One Hundred Thousand Dollars (\$100,000), or imprisoned not more than twenty five (25) years, or both.

Stats., a Class D Felony, and upon conviction may be fined not more than One Hundred Thousand Dollars (\$100,000), or imprisoned not more than twenty five (25) years, or both.

And furthermore, invoking the provisions of Wisconsin Statute 973.042(2), upon conviction for a crime under 948.05 or 948.12 and the defendant is at least 18 years of age at the time of the commission of the crime, the Court shall impose a surcharge of \$500.00 for each image or each copy of an image, as defined in 973.042(1), associated with the crime. The court shall determine the number of images or copies of images associated with the crime by a preponderance of the evidence and without a jury.

The above-named defendant on Wednesday, October 30, 2024, in the City of West Bend, Washington County, Wisconsin, did, having attained the age of 18, knowingly possess **Video: (Khaos) GoB ViP 1-01.mp4** of a child engaging in sexually explicit conduct, and knew or reasonably should have known that the child was under the age of 18, contrary to sec. 948.12(1m) and (3)(a), 939.50(3)(d) Wis. Stats., a Class D Felony, and upon conviction may be fined not more than One Hundred Thousand Dollars (\$100,000), or imprisoned not more than twenty five (25) years, or both.

And furthermore, invoking the provisions of Wisconsin Statute 973.042(2), upon conviction for a crime under 948.05 or 948.12 and the defendant is at least 18 years of age at the time of the commission of the crime, the Court shall impose a surcharge of \$500.00 for each image or each copy of an image, as defined in 973.042(1), associated with the crime. The court shall determine the number of images or copies of images associated with the crime by a preponderance of the evidence and without a jury.

Count 15: POSSESSION OF CHILD PORNOGRAPHY

The above-named defendant on Wednesday, October 30, 2024, in the City of West Bend, Washington County, Wisconsin, did, having attained the age of 18, knowingly possess **Video**: **(Khaos GoB ViP 2-08.mp4)** of a child engaging in sexually explicit conduct, and knew or reasonably should have known that the child was under the age of 18, contrary to sec. 948.12(1m) and (3)(a), 939.50(3)(d) Wis. Stats., a Class D Felony, and upon conviction may be fined not more than One Hundred Thousand Dollars (\$100,000), or imprisoned not more than twenty five (25) years, or both.

And furthermore, invoking the provisions of Wisconsin Statute 973.042(2), upon conviction for a crime under 948.05 or 948.12 and the defendant is at least 18 years of age at the time of the commission of the crime, the Court shall impose a surcharge of \$500.00 for each image or each copy of an image, as defined in 973.042(1), associated with the crime. The court shall

determine the number of images or copies of images associated with the crime by a preponderance of the evidence and without a jury.

And furthermore, invoking the provisions of Wisconsin Statute Section 939.617, upon conviction the Court shall impose a bifurcated sentence including a term of initial confinement for at least three years.

PROBABLE CAUSE:

Complainant prays that said defendant be dealt with according to law. Complainant is a sworn officer with the City of West Bend Police Department and bases their information upon review of the official police report of Detective Brock Bateman of the West Bend Police Department who reported that he was assigned to assist in a suspected possession of child pornography case that came forward from the National Center of Missing and Exploited Children (NCMEC) through a Cyber Tip which was reported to the Department of Justice on or about September 6, 2024. Detective Bateman received information from the Department of Justice, Department of Criminal Investigation, Criminal Analyst Alyssa Crain regarding a Cyber Tip from Google in reference to Ryan Murphy, the defendant herein, that 82 reported files characterized as child sexual abuse material had been uploaded on September 5, 2024, at 8:43 CST. There were associated account: email addresses with the XXXXXXa date of birth, a mobile phone, and a login IP address of with an internet service provider for the IP address identified as AT&T. Special Agent Crain obtained an Administrative Subpoena for AT&T to disclose subscriber information, service address, and the duration of the assignment for the IP address. Detective Bateman received information that on October 21, 2024, AT&T provided the requested records reporting that IP address was assigned to Ryan Murphy at XXX, in the City of West Bend, Washington County, Wisconsin, since July 31, 2024; and a phone number XXXXX and an email address: XXXXXXX

Detective Bateman reported that he reviewed the 82 images/videos uploaded to the google account attached to the Cyber Tipline Report, and noted that some of the files overlapped each other and that some still images were captured from the videos. Detective Bateman reported that the files depicted child sexual abuse material, and all of the children depicted in the images appear prepubescent and on as approximately 18 months old. Detective Bateman submitted the MD5 has values from the 82 files in this Cyber Tipline Report to the NCMEC portal which identified one Hash Value as containing an identified child, 68 Hash Values characterized as "Recognized," and 13 characterized as "Unrecognized." Detective Bateman was able to verify through various records that Ryan D Murphy is associated with the residence, and obtained a search warrant for residence, Ryan D Murphy, a vehicle, and all electronics within the residence.

Detective Bateman reports that on October 30, 2024, at 5:45 a.m., he and members of the West Bend Police Department executed the search warrant at City of West Bend, Washington County, Wisconsin, and identified the sole occupant as Ryan D Murphy, the defendant herein. Detective Bateman spoke with the defendant in the front passenger seat of his squad, and defendant made statements which statements complainant believes as statements against defendant's penal interest, wherein defendant confirmed he has lived at the residence since July 15, 2024, and lives by himself. Defendant confirmed his

provider was AT&T, defendant provided email addresses, internet Defendant admitted he received a text notification that his email was suspended, which he had created about 10 years ago. Defendant stated he viewed pornography once or twice a week through PornHub.com. Defendant stated he purchased a female's month long subscription for \$10. When asked about adult diapers and onesies found in the residence, defendant stated he has addiction to Adult Baby Diaper Lover since freshman year of college. Defendant stated that he has a fascination over wearing the diapers, and wears them for comfort. Defendant stated that he meets other people with the same fetish on the application "Fet Life." Defendant stated that he also uses the website "diaperbois.com" to meet other men with a diaper fetish and to communicate with them. Defendant stated that he visited a website, "TBModels.com" which stands for team boys, and bought \$100 worth of files from the website. Defendant stated the purchase was of three (3) zip files, one called "Star Diaper." Defendant stated that he anticipated the file containing 14-15 year old boys wearing diapers and posing. Defendant stated the other two zip files were called "dark web," and "dark web 2," which he discovered contained child pornography. Defendant stated the thumbnails associated with the purchase depicted 14-15 year old boys in diapers.

Detective Bateman obtained a post-Miranda statement from the defendant, which statement complainant believes as a statement against defendant's penal interest, wherein defendant stated that once he realized the files he purchased contained child pornography, he tried to delete them but was not able to do so. Defendant worked in the Information Technology Department at his job, and Detective Bateman questioned defendant about his computer abilities. Defendant stated in September 2024, he used cryptocurrency to purchase three zip files from TBModels.com defendant stated he was interested in young teen boys wearing diapers. Defendant stated once he purchased the files, he downloaded them to the D Drive on his computer. Defendant stated he attempted to upload the files to this Google driver, but then received the text message from Google saying his account was suspended. Defendant stated he then looked at the majority of images included in the files and observed many of them were child pornography. Defendant admitted he did not try to delete the images immediately. Defendant stated for about the next month he would view the child pornography about once a week. Defendant claimed he made an attempt to delete the child pornography in October because he was disgusted with himself. Defendant estimated the files he bought included approximately 200 images. Defendant stated that he did not masturbate to the child pornography or the teens in diapers, he only looks at the images. Defendant, whose residence is within 400 feet of a school, stated he has never recorded any children himself, is not attracted to children, and has never had sexual contact with a child.

Detective Bateman reported that numerous items were removed from the defendant's residence. While on scene, Criminal Analyst Jason Ruff from the Wisconsin Department of Justice, Division of Criminal Investigations completed a forensic download of defendant's phone and computer hard drives. Analyst Ruff flagged nearly 200 files of suspected child sexual abuse material on the hard drive of defendant's laptop computer recovered next to the defendant's bed. After locating the 200 files, Analyst Ruff discontinued his search.

Detective Bateman reviewed several of the files extracted from the defendant's computer, and observed that several of the images depicted prepubescent males engaged in sexual acts. Detective Bateman describes 15 files as follows:

As to Count 1: File Name: Jura 4.avi

This file is a 3 minute and 30 second video. The video starts with a logo of a diamond with "Hidden Gem" written above it. The video then has the words "Jura's pleasure..." 13 seconds into the video, a juvenile male, approximately 9-12 years old (the same male depicted in the files associated with the CyberTip), is shown completely naked seated on a wooden table. The juvenile male subject is leaning back, bracing himself with his hands behind him. Based on the physical size, what appears to be an adult male (with his face blurred out) is performing oral sex on the child by placing the child's penis into his mouth. The adult male has his hand wrapped around the child, with his hand place on the child's upper buttocks/lower back. The adult continues to perform oral sex on the child and stroking the child's penis with his right hand until 2 minutes and 35 seconds into the video. The child is then shown close up, showing is exposed and erect penis. An adult male erect penis can also be scene in the screen as a hand fondles the child's penis and testicles. The child then grabs the erect male penis with his right and and begins stroking it up and down. The male erect penis ejaculates and the video ends.

As to Count 2: File Name: Jura 93 - Coder.wmv

This file was part of the compilation described in the CyberTip. The video is 10 seconds long and shows two children performing oral sex on one apparent adult, erect penis. The two male children are seated, and the adult male is recording them with the camera pointed straight down. One child's erect penis is depicted in this video. Both children are observed licking and sucking on the penis. The age of the second child is unclear; however, has a similar stature to the 9–12- year-old child.

As to Count 3: File Name: 11yo Cute Chinese Boy Fucked Deeply But Gently

This file is a 13 minute and 50 second video. The video starts by showing a boy approximately 8-11 years old leaning forwarded against a rock. The child is wearing a blue and white jump suit. The child's pants are pulled down to his thighs, exposing his bare buttocks. An adult male is shown standing behind the child and appears to be inserting his right index finger into the child anus. A third subject is clearly holding the camera to capture the abuse. At 13 seconds into the video the adult male pulls down his pants and exposes his penis. The adult male then moves the child to a position where the child is laying on the rock with his feet off the ground. The adult male is scene holding a pink tear drop shaped item, commonly referred to as a butt plug. The adult grabs a clear bottle of liquid and squeezes it on the child's anus. 50 seconds into the video, the adult male leans over the child and begins rubbing his penis in-between the child's buttocks. At 1 minute and 4 seconds the child is seen showing a facial expression commonly associated with pain. The adult male backs away from the child while stroking his own penis. The adult male inserts his left index finger into the child's anus. The adult male then uses his thumbs to spread the child's buttocks. The child then grabs and spreads his own buttocks apart. The adult male again leans toward the child and rubs his penis between the child's buttocks. The adult male subject continues to stroke his own penis and placing his penis between the child's buttocks until 2 minutes and 27 seconds into the video. The adult male backs away and appears to be giving the child verbal instructions to move. At 2 minutes and 56 seconds the child lays on his back, with his knees pulled to his chest. The child's testicles are exposed at this time. The adult male approaches the child and applies a clear substance to his penis and the child's anus. At 3 minutes and 16 seconds the adult male inserts his left index finger into the child's anus. At 3 minutes and 25 seconds the adult male attempts to insert his erect penis into the child's anus. The adult male continues to stroke his penis with his right hand while inserting his left index finger into the child's anus. This continues until 3

minutes and 53 seconds into the video. The adult male then pushed the child's legs further back (towards the child's head), spreads the child's anus with his thumbs, and begins inserting the tip of his penis into the child's anus. After a few seconds the adult male goes back to stroking his penis. At 4 minutes and 49 seconds, the adult male rubs the child's testicles and penis. The adult male then inserts his left index finger back into the child's anus. At 5 minutes and 13 seconds the adult male again attempts to engage in penis to anus sexual intercourse with the child. At 5 minutes and 47 seconds the adult male again applies a clear liquid to his penis and the child's anus. At 6 minutes and 49 seconds, the adult male fully inserts his erect penis into the child's anus. The child can be heard whining "ah". The camera moves to the child's face who has his eyes shut and his mouth open, in a yelling or screaming manner. The adult male can be see thrusting while still leaned over the child. The adult male continues to have penis to anus sexual intercourse on and off with the child until the end of the video. The subject's are speaking an unknown language throughout the video.

As to Count 4: File Name: 12yo Boy Good Movie

This file is a 3 minute and 13 second long video. The video begins with a fully developed male penis, covered in pubic hair, being inserted into a child's anus. The child's penis is exposed and not developed. 2 seconds into the video, the child's face is exposed and shows the child to be completely naked. The child is approximately 9-12 years old. The adult male penis is removed from the child's anus and the child begins stroking the penis with his right hand. This continues until 26 seconds into the video when the child leans back and the adult male again inserts his penis into the child's anus. The adult male depicted in the video appears to be holding the camera. The picture shown by the camera is zoomed in on the child's penis and the adult penis being inserted into the child's anus. The child appears to be rocking back and forth while holding himself up by his feet and hands posted behind him. At 44 seconds into the video, the child falls backwards onto his back. The child then pulls his legs towards him with his arms behind his knees. The adult male continues having penis to anus sexual intercourse and rubbing the child's penis until 2 minutes and 50 seconds into the video. The camera then zooms in on the child's anus as the adult uses his fingers to spread the child's anus apart. The video ends showing the child's anus and penis.

As to Count 5: File Name: Chinese cuttie moans and gets cummed

This file is a 5 minute and 52 second long video and shows a juvenile male, approximately 10-12 years old, completely naked, seated on a completely naked adult male. The child is seated facing away from the adult. The adult is laid on his back on the a bed. The adult male's face is blurred, however, parts of his face are exposed during the video. The child's erect penis is exposed as the adult male's penis is inserted into the child's anus. The adult male grabs the child by the hips and physically moves him up and down, engaging in penis to anus sexual intercourse with the child. At 41 seconds into the video, the adult reaches around the child and grabs the child's penis. The adult continues stroke the child's penis using his right index finger and thumb while continuing penis to anus sexual intercourse. At 1 minute and 56 seconds the video cuts to the child on his hands and knees with his buttocks towards the edge of the bed. The adult male grabs the child's legs, pulls them apart, steps between the child's legs, and inserts his erect penis into the child's anus. The adult male continues penis to anus sexual intercourse with the child in this position until 4 minutes and 44 seconds into the video. The adult male then physically moves the child, exposing this child's anus to the camera. The adult male spreads the child's buttocks, looking into the child's stretched anus. At 5 minutes and 9 seconds into the video the adult physically moves the child back to the edge of the bed and

continues to engage in penis to anus sexual intercourse with the child until the end of the video.

As to Count 6: File Name: Cum Inside Me Please.avi

This file is a 2 minute and 16 second video. The video shows a male child laying on bed, with his head leaning on the head board, holding a phone in his hands. The child is approximately 10-13 years old and only his naked upper half is exposed by the camera. A voice speaking an unknown language is heard at the start of the video. The child then lays flat on his back. At 9 seconds into the video, an adult male is observed climbing on top of the child. At 15 seconds, the adult male begins kissing the child on the lips. This continues until 58 seconds into the video at which time the adult male moves his body up towards the child, exposing his erect penis. At 1 minute and 6 seconds into the video, the adult male inserts his erect penis into the child's mouth. The adult male thrusts his penis into the child's mouth until 1 minute and 25 seconds into the video. The adult male then returns to laying on top of the child and kissing him on the mouth. At 1 minute and 52 seconds into the video, the adult male again moves up towards the child's face and inserts his penis into the child's mouth. The video ends with both subjects getting up from the bed.

As to Count 7: File Name: Fucked In The Woods.mp4

This file is a 1 minute and 47 second video. The video begins showing a fully developed erect penis with pubic hair, being inserted into a male child's anus. The adult male is stroking the child's erect penis. The camera is being held close the child's penis, only showing the insertion of the adult male penis into the child's anus and the child's penis being stroked by the adult male. At 12 seconds into the video, the camera points at and exposes the child's face. The subjects are speaking an unknown language. The camera continues to go back to a close up of the penis to anus sexual intercourse and the child's face. This continues until the video ends.

As to Count 8: File Name: Spongebob & Daddy.avi

This file is 4 minute and 2 second long video. The video begins showing an adult erect penis with a condom on it. A male child buttocks enters the camera frame from the top and the erect adult penis is inserted into the child's anus. The child's testicles are exposed at this time. The child then leans forward toward the adult male and the the adult male thrusts his penis into the child's anus repeatedly. At 1 minute and 47 seconds into the video the child turns away from the adult (facing the camera) while the adult's penis is still inserted in his anus. The child's penis is exposed to the camera at this time. The adult male continues to engage in penis to anus sexual intercourse in this position until the video ends.

As to Count 9: File Name: Spongebob Every Night Sex with Dad (Light Edtit).mkv

This file is a 1 minute and 16 second video. The video begins showing a male child laying on his back with a surgical mask over his eyes and nose. The child is approximately 5-8 years old. The child's is completely naked and his penis is exposed. An adult penis is penetrating the child's anus. The adult his pushing the child's legs back toward their (the child's) body. The child appears in pain throughout the video and the adult continues to engage in penis to anus sexual intercourse with the child until the video ends.

As to Count 10: File Name: Little Boy Tied Up.avi

This file is a 3 minute and 52 second long video. The video begins showing a male child approximately 7-10 years old seated on what appears to be a hotel bed. The child is wearing a

diaper and instructed by a male voice to lay down. Both the child and the adult male in the video are speaking English in the video. At the beginning of the video, the child says "I say no." The child lays on his back as instructed as says "stop taking pictures, I don't wanna take pictures". The adult male says "sh." The child says "I'm serious" and the adult male responds "another minute." The child says "I get to eat another rice crispy treat...if you take pictures" and the adult responds "yes." The adult then begins rubbing the child's penis on the outside of the diaper. The child says "What are you doing?" and sits up to look at an electronic tablet. The child looks at the adult and says "one minute." The child says "I might pee" as the adult continues to rub his penis on the outside of the diaper. The adult says, "go ahead, seriously, if you gotta pee, pee. I'll catch it." The child says "I can't pee when you're doing that." The adult says, "That would be awesome if you did pee." The child grabs his penis on the outside of the diaper and says "My weiner is like right here, straight up." The adult says, "you got a boner?" The adult continues to rub the child's penis on the outside of the diaper and the slaps the adult's hand multiple times. The child again sits up and the adult instructs him to "lay down, just lay down." The child looks back at the tablet and says "times up." The adult says "no it's not" and instructs the child to rip off the diaper. The child is unable to rip the diaper and the adult instructs "just take it off." The child is hesitant and the adult assists in taking the diaper off the child. The diaper is removed at 2 minutes and 47 seconds into the video. The adult male begins touching the child's penis and says "make it hard again" and "I just want to make it hard again." The child grabs the tablet and puts it in front of his face. The adult flicks and strokes the child's penis until it becomes erect. At 3 minutes and 18 seconds the adult male's face is exposed in the video. The adult male removes his glasses and inserts the child's penis into his mouth. The adult male continues to insert the child's penis into his mouth until the video ends.

As to Count 11: File Name: Little Cock Sucker.mp4

This file is a 11 minute and 6 second long video. The video begins with a exposed child penis facing the camera. The child is only exposed from his belly button to his testicles. A male adult is standing next to the child. The adult male then turns towards the camera, exposing his erect penis which is covered in pubic hair. The child reenters the camera frame and the adult male penis is placed in the child's mouth. The male subject grabs the back of the child's head. A second child can be seen walking past the camera. At 6 minutes and 22 seconds into the video, two male children approximately 11-13 years old enter the camera frame, exposing their faces. The male adult places his penis in-between the two children's mouth and repeatedly thrusts. A fourth subject walks in front of the camera frame; however, it is unknow if the subject is an adult or child. At 9 minutes and 58 seconds, a single child is engaged to penis to mouth sexual intercourse with the adult male. The adult male is stroking his own penis while the head of his penis is in the child's mouth. The video ends with child standing up and leaving the camera frame. This video appeared to be captured in a shower.

As to Count 12: File Name: My Little Friend.mp4

This file is a 15 minute and 35 second video. The video begins showing a child approximately 8-11 years old standing with his hand bounded above his head with a rope. An adult male with multiple tattoos is standing in front of the child manipulating the rope. The child is wearing jean shorts, no shirt, and a necklace. The adult male is wearing no shirt, red shorts, and a black backwards baseball cap. Two seconds into the video, the adult thrust his hips towards the child. The adult wraps the rope around the child's wrists multiple time and then begins tickling the child. This continues until 4 minutes into the video at which time the adult places a white cloth material in the child's mouth and ties it behind the child's head. At 4 minutes and 20 seconds the adult male begins grabbing the child's penis on the outside of his jeans shorts.

The adult male grabs and rubes the child's penis over the shorts. This continues until 8 minutes when the adult readjusts the rope, bounding the child's hands together. At 8 minutes and 52 seconds the adult male unbuttons the child's jeans, places his hands in the child's pants, and rubs his penis. The adult male is also licking the child's face at this time. At 9 minutes and 57 seconds, the adult male pulls down the child's underwear exposing his penis. The adult male begins stroking the child's penis with his right hand. At 12 minutes and 1 second the adult begins completely removing the child's shorts and underwear, leaving the child completely naked. The adult returns to stroking the child's penis with his right hand. This continues until the end of the video.

As to Count 13: File Name: Darkweb 2.0 Preview.mp4

The file is a 2 minute and 30 second video. The video begins showing an adult male standing and a child seated in front of the him. Both subjects appear completely naked. The adult male is holding the child's head with both hands and thrusting his penis into the child's mouth. The child's body and face are later exposed in the video and he is approximately 6-9 years old. This continues until 48 seconds into the video, at which time the child leans back and the adult kisses the child on the mouth while stroking his own penis. The adult is also seen kissing the child's neck and chest. The adult and child's face are clearly depicted in the video. The video ends with the adult and child communicating in an unknown language.

As to Count 14: File Name: (Khaos) GoB ViP 1-01.mp4

This file is a 3 minute and 26 second video. The video is compilation of multiple children engaged in sexual acts. The video begins showing a child approximately 11-14 years old seating facing the camera, completely naked. The child's penis is exposed and child urinates on his face, chest, and stomach. At 29 seconds into the video, "Apophis" "King Chubby" is shown as a logo on the screen. At 36 seconds into the video, two children are shown naked in a bathroom. One child is standing (approximately 7-10 years old) and another child is seated on the ground (approximately 12-14 years old). Both children are completely naked and the 12-14 year old has the 7-10 year old's penis in his mouth. A third subject can be seen recording the act in a mirror. At 42 seconds the same two children are shown in the same bathroom, completely naked. The 12-14 year old his standing while the 7-10 year old is on his knees. The younger child is stroking the older child's penis with his right hand, at 49 seconds the older child's penis is placed in the mouth of the younger child's mouth. At 51 seconds, an adult male penis is shown penetrating the anus of a prepubescent child. The child's penis is exposed in the video. The male subject removes his penis from the child's anus and a white substance, appearing to be ejaculate, comes out of the adult penis and onto the child's groin. At 1 minute and 1 second into the video, a child approximately 7-10 years old and an adult male are shown licking each other's tongues (same adult and child depicted in described video #10). At 1 minute and 5 seconds, two children approximately 12-14 years old are shown engaged in penis to mouth sexual intercourse. On the bottom of the screen, "Game of boys V.I.P 2.0" is displayed. At 1 minute and 20 seconds, two male subjects are shown in a bathroom stall engaging in penis to anus sexual intercourse. The action is being captured by a camera being held above the stall. The genitals of these subjects is not exposed as their clothes are on, but pulled down toward their ankles. Both subjects appear to be children, one approximately 12-14 years old and the other 8-10 years old. At 1 minute and 52 seconds into the video, a male child is shown holding a cell phone or tablet. The camera focuses on the child's clothed buttocks. The video then shows an adult hand pulling the back the child's pants to expose the child's penis. The child appears approximately 9-12 years old. At 2 minutes and 8 seconds into the video, a male child approximately 10-13 years old is shown in a seated

position. The child has his pants pulled down to his thighs. The child has a black cloth over his penis. At 2 minutes and 10 seconds, the same child is shown with his erect penis exposed. The child is stroking his penis. At 2 minutes and 17 seconds, the same child is shown thrusting his penis onto a pillow. At 2 minutes and 23 seconds, a clothed child is shown wearing a blue leopard print onesie facing away from the camera and dancing. At 2 minutes and 27 seconds into the video, what appears to be the same child (based on glasses) is shown facing away from the camera. The child is wearing as shirt and no pants. The child (approximately 12-14 years old) is spreading is buttocks open, exposing his anus to the camera. The video then cuts back to the child dancing in the onesie. At 2 minutes and 35 seconds, an adult penis is shown being inserted into an anus. Based on the physical size of the buttocks, it appears to be a child being anally penetrated. At 2 minutes and 41 seconds, an adult penis is shown ejaculated on the apparent child's anus and buttocks. At 2 minutes and 51 seconds a different adult penis is shown rubbing against a male child's anus. The child's face is depicted in the video and appears approximately 9- 12 years old. At 2 minutes and 56 seconds, two children (approximately 9-12 years old) are shown completely naked. One of the children is stroking the other child's penis. At 3 minutes into the video, the same child and adult licking each other's tongues described, are shown engaged in the same behavior. At 3 minutes and 7 seconds, a naked child approximately 7-10 years old is shown laying on his back with his penis exposed. The camera focus is on the child's penis. An apparent adult hand enters the camera frame and grabs the child's penis. At 3 minutes and 15 seconds, an adult penis is observed penetrating what is appears to be a child's anus. The video ends with a heart shape on the screen.

As to Count 15: File Name: (Khaos GoB ViP 2-08.mp4)

This file is 26 second video. The video beings showing a male child approximately 6-9 years old wearing a green shirt, laying on his back. The child is not wearing any pants, exposing his penis. The child's eyes are closed and he is motionless throughout the video. It is unknown if the child is unconscious. An adult male penis is penetrating the child's anus at the start of the video. The adult male repeatedly penetrates the child's anus before the camera focuses on the child's bare anus. This is how the video ends.

Based on the foregoing, the complainant believes this complaint to be true and correct.
